LISTING AND QUOTATION OF 331,653,000 NEW ORDINARY SHARES IN THE CAPITAL OF THE COMPANY (“CARNARVON SHARES”) AT AN ISSUE PRICE OF S\$0.01615 EACH, TO CARNARVON THAILAND LIMITED PURSUANT TO THE SUPPLEMENTAL AGREEMENT (“CARNARVON SHARES ISSUE”)

The board of directors (the “**Board**” or “**Directors**”) of CWX Global Limited (formerly known as Loyz Energy Limited) (the “**Company**”) refers to the circular to shareholders of the Company dated 12 October 2017 (the “**Circular**”) in relation to, among others, the Carnarvon Shares Issue, as well as the Company’s announcements on 27 October 2017 (in relation to the approval obtained from the shareholders of the Company at the extraordinary general meeting held on the same date in respect of, among others, the Carnarvon Shares Issue) and 10 November 2017 (in relation to the receipt of listing and quotation notice from the SGX-ST for the listing of and quotation for, among others, the Carnarvon Shares).

Unless otherwise defined, all capitalized terms shall bear the same meaning as ascribed to them in the Circular.

The Board is pleased to announce that the Carnarvon Shares Issue has been completed on 14 November 2017, and 331,653,000 Carnarvon Shares have been allotted and issued to Carnarvon on the same day. Further, as announced today, the Company had also allotted and issued 76,628,352 new shares in the capital of the Company (“**AIPL Shares**”) to Arctos Investments Pte. Ltd. on the same day. Please refer to the announcement on the listing and quotation of the AIPL Shares released by the Company today.

Following the allotment and issuance of the Carnarvon Shares (but before the allotment and issuance of the AIPL Shares), the issued and paid-up share capital of the Company has increased from 1,541,727,683 Shares to 1,873,380,683 Shares. The Carnarvon Shares rank *pari passu* in all respects with the existing Shares.

The Carnarvon Shares are expected to be listed and quoted on Catalist on or around 16 November 2017, and trading of the Carnarvon Shares is expected to commence at 9.00 a.m. on the same date.
